Figures on owners placing orders with Japanese yards indicates that 80.2 % of orders are placed by Japanese related owners, European and American shipping companies, 1.8 %; Greek shipowners, 3.3 %; Hong Kong shipowners, 0.0 %; Chinese shipowners, 0.0 %; Oil companies, 0.0 %; and others, 14.7 %.
